

Perrysburg Market Food Truck Vendor 2017 Rules & Application

The Food Truck area of the Perrysburg Market is an exciting new joint collaboration between the Perrysburg Convention & Visitors Bureau/Perrysburg Market and the Toledo Food Trucks Association.

Market Location: Downtown Perrysburg – Louisiana Avenue

Dates & Times: Thursdays, May 11th through October 12th, 2017
Food Truck service from 5-8 pm
Food Truck set up is from 4:30 to 5pm

1. Food Trucks must contact the Toledo Food Trucks Association at (419) 392-2812 to be considered for inclusion in the market. Participation will be at the discretion of the Toledo Food Trucks Association President.
2. Food Trucks may participate in the market only as daily vendors. No full season spots will be secured.
3. Food Trucks must have all applicable licenses and insurance including liability insurance and provide copies of these items along with the completed application form.
4. Vendors must be 18 years of age or older.
5. The daily rental fee for a truck space is \$25 per day. Payment by cash or check is due by Wednesday of each week. Make checks payable to The Perrysburg Convention & Visitors Bureau or Perrysburg CVB and deliver to 105 W. Indiana Ave., Perrysburg OH 43551. A drop slot is available 24 hours a day.
6. A service charge of \$25 will be assessed for any check that is returned for insufficient funds or other causes.
7. No refunds will be issued for any payments received.

8. Food Trucks must contact the Toledo Food Trucks Association President every time they plan to attend the market and will have a parking spot assigned to them each week. Reservations are required one week in advance.
9. Placement of a Truck at the market is at the direction of the Toledo Food Trucks Association President. Particular parking spots cannot be guaranteed.
10. Food Truck setup is from 4:30 pm to 5 pm. Do not arrive before 4:30 pm or later than 5 pm. No sales are allowed after 8 pm.
11. If a Food Truck vendor has arranged to attend and must cancel, they must notify the Toledo Food Trucks Association President no later than 2 pm on market day.
12. Food Truck Vendors may not reassign, loan or in any way transfer their parking space to another vendor.
13. Food Truck Vendors may not share booth space with another vendor.
14. Serving must be done along the curb. As a safety necessity, no business may be conducted in the street.
15. Food Trucks must use self-contained generators for power. No other sources of power may be used.
16. Items, including signs, may not be placed outside of each Truck's designated area. Vendors may not impede pedestrian or motor traffic and may not interfere with the normal operations of the downtown businesses.
17. Food Truck Vendors will present and conduct their business in a first class manner which is not disruptive or disparaging to other vendors or to the market overall. No loud music, shouting or harassing will be permitted. Courtesy and honesty are required.
18. Food Trucks may play music at a low volume. Music must be turned off during Music at the Market concerts.
19. No firearms, alcoholic beverages, drugs, pets or animals - with the exception of assistance animals - will be allowed at any Food Truck parking space.
20. No Vendor shall engage in solicitation, collection drives, political or religious activities at the market.
21. Collusion among Vendors to raise or lower prices or to exert pressure or persuasion to cause any Vendor to increase or decrease selling prices is prohibited.

22. In the event that a Food Truck sells out of product, the Truck may not pull out of the truck line-up before 8 pm.
23. Food Truck Vendors are required to keep their booth area clear of all garbage and must clean their areas at the end of the day or when they leave by removing all refuse, containers, signs, trash, and litter. Garbage must be taken home with the vendor or disposed of within designated trash containers.
24. Food Truck Vendors must bring at least one trash container for use at their truck.
25. Grease stains or cooking residue must be cleaned up each week. A drop cloth or tarp may be used to catch grease and debris.
26. Nothing may be poured or swept into the street or down the storm sewers.
27. *Clean-up is mandatory!* The Perrysburg CVB reserves the right to assess a cleaning charge of \$25/incident to any vendor in violation if they do not perform the necessary clean-up. Please leave the area better than you found it!
28. No vehicles (excluding the Food Truck) belonging to Food Truck vendors or their staff members may be left in any parking spot within the boundaries of the market area between 3 and 8 pm.
29. The Market is open rain or shine. In the event of inclement weather it is up to the individual Food Truck Vendor to decide whether or not to attend. No refunds will be issued.
30. The Perrysburg CVB reserves the right to revise the Perrysburg Market Food Truck rules at any time.
31. The Perrysburg CVB, or its designee, has the authority to deny any person or group the privilege of operation at the market. No vendor will be denied participation for reasons regarding gender, race, handicap, marital status, or religion.
32. The Perrysburg CVB and/or the Toledo Food Trucks Association President reserves the right to remove any Food Truck Vendor who does not comply with the rules stated herein; those that, in their judgment, are using methods or selling items that are detrimental to attendance at the market or contrary to the market policies and standards; or those who fail to obey any lawful order of the Perrysburg CVB, the Toledo Food Trucks Association President or local municipalities.
